# Lone Star Park Concludes 2013 Fall Meeting of Champions with Positive Gains Across the Board

Buoyed by a renovated dirt surface, a new concert series and a record-setting simulcast Breeders' Cup weekend, Lone Star Park concluded its 16th Fall Meeting of Champions for American Quarter Horses on November 9 with positive attendance and handle figures across the board.



"Our 2013 Fall Meeting of Champions was a resounding success," said President and

General Manager Scott Wells. "Our racing surface was safe and fair, which gave bettors across the country the confidence to play our races, and our on-track entertainment gave customers a reason to come see us."

Total all-sources wagering during the 26-day Fall meeting climbed 9.3 percent to \$19,932,959, from last years total of \$18,241,432.

Attendance totaled 83,243 for a daily average of 3,202, an 8.1 percent increase from 2012. On-track betting on live racing and simulcast-in climbed 7.6 percent to \$12,968,393, and off-track export handle rose 12.5 percent to \$6,964,566 versus \$6,193,702.

Because of the gains in attendance and handle, track officials saw fit to increase purses of overnight races during the meet. An increase of over 10 percent, ranging from \$300 to \$800 per race, went into effect on October 10.

The live racing business level increases were also matched by a surge of momentum in the simulcast-in wagering handle. Since July, simulcast-in wagering totals have increased nearly every week, resulting in an 8.1 percent increase.

Highlights during the nine-week meeting included the introduction of the Bud Light Pura Musica Concert Series with three post-race concerts early in the season. The concerts featuring Tejano artists Eddie Gonzalez, Emilio Navaira and Michael Salgado, produced a 45 percent increase in attendance versus the same three nights with no concert in 2012.

Also, the two-day simulcast of the Breeders' Cup Championships on November 1 and 2 resulted in the highest two-day attendance total for Breeders' Cup here since 2008 (the first year of two-day Breeders' Cup Championships). All sources handle for the two-day period was up 19.7 percent from 2012, as well.

There were a total of 2,081 starters during the 26-day meeting. The total amount of purses paid was \$3,347,851, for an average of \$128,764 per day of live racing. The total amount of stakes purses paid during the season was \$2,367,036.

Closing night, topped by the Grade 1, Texas Classic Futurity, the richest race in Texas, and Texas Classic Derby, drew a crowd of 5,007 fans, a 12.6 percent increase from 2012. Kates Dynasty, owned by the partnership of Smith, Windham and Guthrie, trained by Michael Joiner and ridden by Salvador Martinez, won the Futurity. Jody Pops Zoomer, owned by Gary and Randal Kurz, trained by Toby Keeton and ridden by Luis Vivanco, won the Derby.

Jockey Rodrigo Vallejo earned his first riding title at Lone Star Park with 20 wins from 98 starts. Judd Kearl won his third training title at the Grand Prairie track with 20 wins from 85 starts. His previous titles were from 2006 and 2007. The leading owner title went to Bobby D. Cox, with a total of five wins at the meet. This was his first title.

The track record of :19.080 for 440 yards, set in 1997 during the inaugural Fall Meeting of Champions by Dashing Perfection, was broken on October 18 in the Texas Classic Derby trials by Jody Pops Zoomer with a time of :19.075. Jody Pops Zoomer went on to win the 21st running of the Derby here on November 9.

Lone Star Park's 76-day, 2014 Spring Thoroughbred Season begins on April 10, 2014 and concludes July 12, 2014.

# Retama Park Thoroughbred Meet Underway, New Hall of Fame Class Inducted November 16

Retama Park's 2013 Thoroughbred meet kicked off Friday, October 4. Racing will continue on Friday and Saturday nights through December 28, with a first post time each evening of 6:45 p.m.

Saturday, November 16 marked both the beginning of the meet's stakes schedule and the 13th annual Texas Horse Racing

Hall of Fame Gala. The 2013 class of inductees into the Texas Horse Racing Hall of Fame included Dr. Glenn Blodgett, a veterinarian and leading American Quarter Horse breeder; Tami Purcell-Burklund, the leading female Quarter Horse jockey in history; Dashingly, a top Quarter Horse racemare; Arthur Seeligson Jr., a Thoroughbred owner and breeder who campaigned 1975 Belmont Stakes winner Avatar; Kontiki, a top Arabian sire and racehorse; and Hadif, a perennial leading Thoroughbred stallion in Texas that stood at Valor Farm.

The Joann Weber Distinguished Service Award was presented posthumously to Jeff Coady of Coady Photography.

All proceeds derived from the gala benefit the Texas Horse Racing Hall of Fame, a non-profit organization dedicated to preserving the legacy of the horse racing industry and those individuals who have influenced and contributed to its growth and development.

In the \$50,000 Texas Horse Racing Hall of Fame Stakes for three-year-olds and upward that evening, Southwestern Racing LLC's homebred three-year-old gelding Special U F O established a big early lead and never looked back on his way to an easy 3 ½ lengths victory, getting 1 1/16 miles in 1:40.95. Ridden by Junior Chacaltana, it was Special U F



O's fourth consecutive win for trainer Danny Pish. His record now stands at 10-5-0-1, with earnings of \$70,692.

In the \$50,000 Fiesta Mile for fillies and mares that night, owner/breeder Sylvia Baird's four-year-old filly Smiles Golden Song enjoyed a stalking trip under jockey David Cabrera before drawing clear to win

by 2 ¼ lengths. The Larry Stroope trainee stopped the clock in 1:34.62 for one mile on the grass while winning the Fiesta Mile for the second consecutive year.

Also that evening, owner/trainer Christine R. Byrom's Billy Jacks took the \$20,000 Texas Arabian Derby (Gr. 3) by 3 1/2 lengths over Lil Wayne in 2:01.29 for 1 1/16 miles under jockey Ivan Arellano. Mark Kulow's Zells Follies, ridden by Alfredo Contreras, held off Etres Chic by a neck in the \$20,000 Texas Arabian Oaks in 1:55.66 for one mile. She is trained by Kenny Massey.

On November 9, John B. Evans' and owner/trainer Terry Eoff's Sky's Goldmaster took the \$75,000 M2 Technology Stakes for two-year-old fillies by one length over a rallying Redgrass Cat in 1:36.47 over a firm turf course. She was ridden to victory by Ernest Valdez-Jiminez. In the \$75,000 El Jovan Stakes for two-year-old colts and geldings, Agave Racing Stable's Broadway Missile dueled with Margarita Bibb early, took the lead in early stretch, and just held off Kenneth L. & Sarah K. Ramsey's Perky Kitten by a nose in 1:36.12 for a mile over the firm turf course. Broadway Missile is trained by Michelle Lovell and was ridden to the win by Luis Quinonez.

### Wagering, Purses Up, Race Days Down in October

Compared to October of 2012, wagering in October of this year was up 8.3 percent (\$804,303,623 versus \$742,671,714, and purses were up a slight 0.31 percent (\$93,286,965 versus \$92,998,608). However, race days were down 5.76 percent (409 versus 434).

Comparing the first ten months of 2013 with 2012, wagering overall is up slightly - 0.56 percent (\$9,268,404,702 versus \$9,216,492,185). Purse are also up slightly - 0.30 percent (\$951,152,650 versus \$948,317,293), and race days are down 3.2 percent (4,449 versus 4,596).

### American Horse Council Briefs Congressional Staff on Soring Bill



On October 28, the American Horse Council briefed a large number of House and Senate Congressional Staff on the Prevent All Soring Tactics Act of 2013 (H.R. 1518/S.1406) (PAST Act) that would strengthen the 40 year old Horse Protection Act to prevent horse soring.

Soring is an abusive practice used by some in the Tennessee Walking Horse, Spotted Saddle Horse, and Racking Horse industry. It usually involves the use of action devices, chemicals, pads, wedges or other practices to cause pain in the horse's forelegs and produce an accentuated show gait for competition. Despite the existence of a federal ban on soring for over 40 years, this cruel practice continues in some segments of the walking horse industry.

The PAST act would amend the HPA to prohibit a Tennessee Walking Horse, a Racking Horse, or a Spotted Saddle Horse from being shown, exhibited, or auctioned with an "action device," or "a weighted shoe, pad, wedge, hoof band or other device or material" if it is constructed to artificially alter the gait of the horse and is not strictly protective or therapeutic. These new prohibitions would not apply to other breeds that do not have a history of soring.

The legislation would also increase fines and penalties for violations, including the potential for a lifetime ban for repeat offenders.

The bill would create a new licensing process for horse show inspectors, eliminating the current designated qualified persons (DQPs) program, which the U.S. Department of Agriculture considers ineffective. The bill would require the USDA to train, license and appoint new independent inspectors for shows and other HPA-regulated activities that wish to hire an inspector. Licensed or accredited veterinarians would be given preference for these positions. The decision to hire and pay for an inspector would still reside with the management of a show, sale or auction.

Most major national horse show organizations support the PAST Act, including the American Horse Council, the American Association of Equine Practitioners, U.S. Equestrian Federation, the American Quarter Horse Association, the American Paint Horse Association, the American Morgan Horse Association, the Pinto Horse Association of America, the Arabian Horse Association, the American Saddlebred Horse Association, the United Professional Horsemen's Association, the Appaloosa Horse Club and many other state or local organizations.

The PAST Act has attracted wide bi-partisan support. The House bill currently has 216 co-sponsors and the Senate bill has 26 co-sponsors. New co-sponsors are being added almost daily, and the AHC hopes for quick passage of this important bill.

# The Jockey Club Releases 2013 Report of Mares Bred Statistics



On October 17, The Jockey Club released Report of Mares Bred (RMB) statistics for the 2013 breeding season. Based on RMBs received through October 10, 2013, The Jockey Club reports that 1,698 stallions covered 34,174 mares in North America during 2013.

The annual statistics represent approximately 90 percent of the mares that eventually will be reported as bred in 2013. According to historical trends, The Jockey Club expects to receive RMBs representing an additional 3,000 to 4,000 mares bred during the 2013 breeding season.

The number of stallions declined 8.8 percent from the 1,861 reported at this time in 2012, and the number of

mares bred fell 3.4 percent from the 35,391 reported at this time last year.

The number of stallions covering 100 or more mares increased by one, from 87 in 2012 to 88 in 2013. These stallions accounted for a greater percentage of the total mares reported bred this year - 34.0 percent of all mares bred in 2013 versus 31.9 percent of all mares bred in 2012 as reported at this time last year. RMB statistics for all reported stallions in 2013 are available through the Publications & Resources section of The Jockey Club's website at <u>www.</u> <u>jockeyclub.com</u>.

Further book size analysis shows a 2.9 percent increase in the number of mares bred to stallions with a book size of 100 or more in 2013 when compared to 2012 as reported at this time last year; an 11.6 percent decrease in mares bred to stallions with a book size between 75 and 99; an 11.3 percent increase in mares bred to stallions with a book size between 50 and 74; a 15.9 percent decrease in mares bred to stallions with a book size between 25 and 49; and a 5.3 percent decrease in mares bred to stallions with a book size fewer than 25.

The stallion Into Mischief led all stallions with 210 mares bred in 2013. Rounding out the top five were Archarcharch, 187; Harlan's Holiday, 187; Kitten's Joy, 184; and Majestic Warrior, 176.

Kentucky traditionally leads North America in Thoroughbred breeding activity. During 2013, Kentucky's 235 reported stallions covered 15,695 mares, or 45.9% of all of the mares reported bred in North America. The number of mares bred to Kentucky stallions increased 2.2 percent compared with the 15,361 reported at this time last year.

Of the top 10 states and provinces by number of mares reported bred in 2012, only Kentucky, Oklahoma, and Texas stallions covered more mares in 2013 than in 2012, as reported at this time last year.

# NTRA, 50 Other Industry Organizations Call on Regulators to Adopt Uniform Rules



The National Thoroughbred Racing Association (NTRA) sent a letter to pari-mutuel regulators in early October urging them to adopt uniform national reforms addressing much-needed changes to medication regulation, enforcement and labo-

ratory testing. The letter was co-signed by more than 50 racetracks and industry organizations.

The letter specified several uniform national reforms, including the adoption of recently developed model medication guidelines, inclusion in a multiple violator penalty system and participation in laboratory accreditation and quality assurance programs.

The reforms have been extensively researched and developed by the Racing Medication and Testing Consortium (RMTC), the industry's scientific advisory organization consisting of 25 major racing industry stakeholder organizations and the Association of Racing Commissioners International (RCI), the industry's association of state regulatory bodies responsible for the integrity of racing. RCI voted to incorporate the reforms into their official Model Rules earlier this year. Individual regulatory bodies must now move to adopt the reforms in each racing jurisdiction.

The letter included 60 pages of exhibits detailing the rules that need to be adopted. The full text of the cover letter and exhibits are accessible online at <u>http://www.ntra.com/feeds/testingrules.html</u>.

Earlier this year, eight states in the Mid-Atlantic and Northeast jointly agreed to implement the reforms on January 1, 2014, or when a participating state's live racing begins in 2014. The states committed to implementing the reforms are Delaware, Maryland, Massachusetts, New Jersey, New York, Pennsylvania, Virginia and West Virginia. Several other states are in the process of adopting these reforms, as well.

"Nationwide adoption of these reforms is essential to safeguarding horses and riders and providing uniformity to fans and participants alike. If you have not done so already, we urge you to commit to the reforms and move expeditiously to adopt all aspects of the reforms," wrote Alex Waldrop, President and CEO of the NTRA and newly elected Chairman of the RMTC. Commissioners were told to expect direct contact from industry representatives to determine their commitment to the reforms and timeline for adoption. They were also advised to contact the RMTC for any scientific expertise or documentation needed to support the reforms.

RMTC Board Eliminated Stanozolol Threshold, Elects Waldrop Chair at September Meeting



The board of directors of the Racing Medication and Testing Consortium (RMTC) held a regular meeting September 17 in Denver,



Colorado. At that meeting, the board:

- Unanimously voted to recommend that stanozolol be eliminated from those substances with an RMTC recommended threshold level and to present that revision to the Association of Racing Commissioners International (RCI) for its adoption. The previous threshold allowed stanozolol to be administered up to about 30 days prior to racing. The removal of the threshold means that stanozolol will become a prohibited substance in jurisdictions adopting this recommendation and can no longer be present at any concentration in a horse on race day. Stanozolol is a synthetic anabolic steroid that was previously marketed as Winstrol<sup>™</sup> but is now only available as a compounded product.
- Voted to grant Interim Accreditation status to the Ohio Department of Agriculture Racing Laboratory. The Ohio Department of Agriculture Laboratory will become the third fully accredited laboratory upon successful completion of a site inspection, as it has previously fulfilled the other requirements for RMTC accreditation. The University of California-Davis Kenneth L. Maddy Laboratory and HFL Sport Science Inc. Laboratory in Lexington, Kentucky, were the first two laboratories to be accredited by the RMTC, and five other laboratories have applied for accreditation.
- Voted to support the effort for nationwide adoption of uniform medication rules, penalties and laboratory accreditation reforms, and directed RMTC staff to provide any scientific expertise needed by racing commissions to support adoption of these reforms.
- Voted to form a committee to review the existing model rule for out of competition testing and to recommend any necessary changes to the protocol for the collection and testing of out of competition samples at the request of The Jockey Club.
- Voted to authorize the RMTC's Scientific Advisory Committee to explore whether the scientific research will support separate medication rules for Standardbreds in regard to the withdrawal times for clenbuterol and intra-articular corticosteroids at the request of the United States Trotting Association.
- Elected Alex Waldrop, president and chief executive officer of the National Thoroughbred Racing Association, to succeed Dr. Bobby Lewis as chairman of the RMTC board. Lewis, who served as chairman for the past six years, will continue to represent the American Association of Equine Practitioners on the RMTC board. "I am very proud of what the RMTC has accomplished since its inception," stated Dr. Lewis. "I look forward to seeing the implementation of the National Uniform Medication Reform program that has been the focus of much of our work over the past six years."

### The Jockey Club Releases 2012 Breeding Statistics



On September 13, The Jockey Club reported that 2,392 stallions covered 37,908 mares in North America during 2012, according to statistics compiled through September 9, 2013. These breedings have resulted in 22,001 live foals of 2013 being reported to

The Jockey Club on Live Foal Reports received as of September 9, 2013.

The Jockey Club estimates that the number of live foals reported so far is approximately 90 percent complete. The reporting of live foals of 2013 is down 2.2 percent from last year at this time when The Jockey Club had received reports for 22,500 live foals of 2012.

In addition to the 22,001 live foals of 2013 reported through September 9, The Jockey Club had also received 2,891 No Foal Reports for the 2013 foaling season. Ultimately, the 2013 registered foal crop is projected to reach 23,000.

The number of stallions declined 8.7 percent from the 2,620 reported for 2011 at this time last year, while the number of mares bred decreased 4.8 percent from the 39,838 reported for 2011.

The 2012 breeding statistics are available alphabetically by stallion name through the Publications and Resources link on The Jockey Club homepage at <u>www.jockeyclub.com</u>.

Matt Iuliano, The Jockey Club's executive vice president and executive director, stated that the breeding statistics are not a measurement of the live foals born in each state or province, but are a count of live foals by conception area, regardless of where the foals were born. He also reiterated that the statistics should not be taken to represent the final fertility record of any single stallion or conception area.

Kentucky annually leads all states and provinces in terms of Thoroughbred breeding activity. Kentucky-based stallions accounted for 41.1 percent of the mares reported bred in North America in 2012 and 48.8 percent of the live foals reported for 2013.

The 15,569 mares reported bred to 249 Kentucky stallions in 2012 have produced 10,726 live foals, a 2.1 percent decrease on the 10,960 Kentucky-sired live foals of 2012 reported at this time last year. The number of mares reported bred to Kentucky stallions in 2012 declined 2.2 percent against the 15,918 reported for 2011 at this time last year.

Among the 10 states and provinces in which stallions covered at least 1,000 mares in 2012, only Florida and New York stallions produced more live foals in 2013 than in 2012 as reported at this time last year. ### The Jockey Club Announces Plan to Fund Baseline Concussion Tests for Jockeys



On November 6, The Jockey Club announced that it will fund baseline concussion testing for all jockeys who use the Jockey Health Information System (JHIS).

The JHIS, which was created in October 2008, is a database that stores jockeys'

updated medical histories and enables emergency medical personnel at racetracks to instantly access that information in the event of injury. There is no cost for any racetrack or jockey to participate in the JHIS. It can be accessed via a new module of InCompass' Race Track Operations system.

"Baseline concussion testing has become an integral part of any safety regimen in professional and amateur sports alike," said James L. Gagliano, president and chief operating officer of The Jockey Club. "The topic was addressed at the International Jockeys' Health, Safety & Welfare Conference at Monmouth Park in September, and we've all read about the testing being done with football players and, most recently, NASCAR drivers. We are pleased to use the platform of the JHIS to offer this service to the riders."

"On behalf of the Jockeys' Guild and its members, I want to truly thank The Jockey Club for its continued support for the welfare of riders," said Terry Meyocks, national manager of the Jockeys' Guild. "It is my hope that every rider will take advantage of this opportunity, and we look forward to working with the tracks and riders to see that it is widely promoted."

The creation and development of the JHIS featured collaboration among InCompass, The Jockey Club Technology Services Inc., the Jockeys' Guild, Keeneland and Dr. Barry Schumer, Keeneland's medical director, who developed the original concept and consulted on the project. Keeneland is the only track in the country that requires jockeys to sign up for the JHIS.

InCompass, a subsidiary of The Jockey Club, plans to acquire a package of these tests, which would be administered free of charge by a medical professional at each track if the rider agrees to enroll in JHIS.

The statistics include 322 progeny of stallions standing in North America but foaled abroad, as reported by foreign stud book authorities at the time of publication. In this category, 103 live foals by North American stallions were reported from Republic of Korea, 60 from Great Britain, and 42 from Ireland. Remaining countries on the list are Philippines, 23; Japan, 19; Mexico, 17; Brazil, 13; France, 11; Jamaica, 10; Argentina, 5; India, 5; Thailand, 5; Qatar, 3; Chile, 2; Dominican Republic, 2; Ecuador, 1; Sweden, 1.

The report also includes 75 mares bred to 30 stallions in North America on Southern Hemisphere time. The majority of these mares have not foaled.

### TAA Hires James Hastie as Executive Director

On November 8, the Thoroughbred Aftercare Alliance (TAA) announced that it had hired James Hastie as the organization's Executive Director. Mike Ziegler, who has served as the TAA's Executive Director since March of 2012, will remain with the organization through a transition period before returning full-time to his role as Executive Director of the NTRA Safety and Integrity Alliance.

Hastie joins the TAA from Cazenovia, New York. Most recently he served as Major Gifts Officer for the American Red Cross in Syracuse, New York. # **Texas Horsemen's Bookkeeper FAQ**

Below you will find some of the more commonly asked questions regarding the operation of the Horsemen's Bookkeeper in Texas. If you don't find the answer to your question here, please send us an e-mail with your question to <u>Marsharountree@texashorsemen.com</u> or call us at (512) 467-9799 and we will be happy to answer any questions you might have.

# **Q-** Why does the horsemen's organization operate and manage the horsemen's bookkeeper?

A- The funds held in the horsemen's bookkeeper account belong to horsemen and at no time belong in the bank accounts of the racing associations. The horsemen's organization is fully qualified and prepared to conduct the business of the horsemen's bookkeeper.

### Q- How do I open an account?

A- When you enter a horse in a race at a Texas track, an account is automatically generated for you.

# **Q-** Why is the name on my account different from my actual name?

A- The account is named exactly as the name appears on the horse's registration papers. This information comes from the racing office and is downloaded into the horsemen's bookkeeper system.

# **Q-** Can I change the name on the account once it has been opened?

A- No, the name must remain the same as the ownership on the horse's registration papers. Changing the name of the account would result in another account being created the next time the horse drew into the body of a race. You should always register a horse in the exact name that you want your bookkeeper account to be named.

# **Q-** My horse won purse money in a race, but it doesn't show up on my account. Why?

A- Ask the bookkeeper to check for other accounts that may have been automatically created with a similar name. For instance, if you registered and ran a horse under the name "John Doe," then registered another horse under the name "J. Doe," then two accounts may have been generated, and the race was perhaps posted under the other name. This is why it is best to always register your horses in the same name, if possible.

# **Q-** I submitted a W-9 form last year. Why do I have to prepare another one this year?

A- In order to comply with IRS requirements, we must have a completed W-9 each year.

### **Q-** Can I use my social security number for my partnership account?

A- You can use your social security number for partnership accounts, but keep in mind that any earnings will be reported to the IRS as income for your social security number. If you use your personal tax number, the name on the account must have your name, followed by the partnership name. The tax number must match the first name on the

### Q- My tax form 1099 is wrong. How can I get it corrected?

A- If the 1099 has the wrong earnings amount, please make sure that you have looked at your year-end statement to verify earnings before you call our office for a corrected tax form. A 1099 that is indeed in error may be corrected by calling the Austin office of the Horsemen's Bookkeeper at (512) 467-9799.

### Q- I write checks for jock mounts and make other deposits payable to the Horsemen's Bookkeeper for my racing account. Should I send a 1099 to the Horsemen's Bookkeeper?

A- You should not send a 1099 to the Horsemen's Bookkeeper. Any expenses that you incur as a result of your racing operation might be used as a deduction on your tax return. Discuss this with your tax professional to determine what items are deductible and whether or not you should send 1099s to other persons that you have paid.

### Q- Do I need to send a 1099 to my jockey?

A- No, you do not need to send a 1099 to the jockeys. The Horsemen's Bookkeeper sends the tax forms to all of the jockeys at the same time that the forms are mailed to the owners. Please discuss with your tax professional the possibility of using riders' fees as a deduction in your race operation.

### Q- Can I use money in my account to pay my trainer?

A- You can request that money from your account be transferred into your trainer's account.

### Q- Why can't a check be written from my account to my vet?

A- Checks may only be issued in the name of an account holder. Veterinarians, farriers and other equine professionals do not have accounts within the bookkeeper system. Therefore, no money may be transferred to those persons.

# **Q-** Can I make stakes payments to a racetrack from my account?

A- You may request that funds be transferred from your account for nominations, stakes payments, or entry and start fees. Be aware that the transfers are dated, and as such need to be made in a timely manner according to the due date for stakes payments.

# Q- The race meet was over at Lone Star Park and I didn't receive a check for my account balance. Why?

A- Although each racetrack has a bookkeeper employed by the horsemen's organization, the bookkeeping system is a statewide system similar to branch banking. When you start a horse in Texas, you are entered into the system, and you will have one account for all of your racing activity in the state. Each transaction, regardless of which Texas track generated it, will appear on one statement. The Horsemen's Bookkeeper does not clear accounts and mail checks without a request from the account holder.

# Q- I want to claim a horse at another Texas track although I am racing at Lone Star. How can I do that?

A- One of the benefits of a centralized bookkeeper system is that you may access your funds at any Texas track. The money that you have in your horsemen's account is available at any time at any Texas track.

### Q- I tried to cash a check from my horsemen's account at a local Frost Bank, and they charged me a fee. If the Horsemen's Bookkeeper uses this bank, why do I have to pay a check cashing fee?

A- While the Horsemen's Bookkeeper account is at Frost Bank, if you do not have an account there, you will be charged a small fee for cashing your check. Frost Bank is one our corporate partners and offers great benefits, as well as cost savings, to horsemen who maintain accounts at Frost Bank. Why not check it out and see if they can be of service to you?

### Q- I called a bookkeeper to get my account balance, and she said I had a negative balance. How can this be since I won purse money this week?

A- Most likely, the purse that you won is on hold by steward's order. The bookkeeper system automatically charges your account for the jockey fees as soon as the race is run. This can put your account into a negative mode until the purse is released and posted to your account.

# Q- I won a race two weeks ago, and the purse is still on hold. Why?

A- Purse earnings for first and second place are automatically placed on a steward's hold pending test results. There are also holds placed on random finish positions at any given time by the stewards. The Horsemen's Bookkeeper cannot release purse funds until the stewards of the Texas Racing Commission release the hold and authorize payment. If you have questions regarding a hold on purse funds, please call the Texas Racing Commission at (512) 833-6699.

# Q- I noticed that I was charged for photo fees, and I never received my win pictures. What can I do?

A- Charges for photos and videos are deducted from your horsemen's account on the day that the photos were ordered. In the case of missing photos or disputes regarding photos, please call the track photographer's office for assistance. The Horsemen's Bookkeeper cannot resolve issues relating to photos or videos.

# Q- I would like to have access to my horsemen's account online. Is it possible to view my statement on the internet?

A- You may view your horsemen's account statement online at any time. Please call our Austin office at (512) 467-9799 to request information on setting up your online account access.

### **Q- I requested a check from one of the bookkeepers,** and she said I would have to come back in an hour. Is this normal? And why can't I get my check immediately?

A- In most instances, the bookkeepers will be happy to issue a check on the spot when you request funds from your account. During particularly busy times and during the races, they may ask that you return at a later time to pick up a check. During the races, the bookkeeper is busy posting results and verifying claim funds, as well as recording deposits and other transactions within the bookkeeper system. Your check will be available as soon as possible, and if you are in a hurry and must leave before the check is ready, we will be happy to mail it to you.

### Q- My trainer called a bookkeeper and asked for a copy of my statement so that he could prepare his training bill for the month. His request was denied. Why?

A- Individual statements within the horsemen's bookkeeper system record all of your transactions, not limited to purse earnings. These statements have your social security or tax identification number on them and are considered to be personal and confidential. Think of your horsemen's bookkeeper account as a bank account, and you will understand why they cannot be shared with other persons. If you would like for your trainer to have a copy of your statement, you can send it to him or her at any time. Privacy matters prevent us from divulging your account information to anyone other than yourself.

### Q- My trainer needs access to my horsemen's account and the funds that I have in there in order to make stakes payments and to claim horses for me. What needs to be done to provide this access?

A- The Texas Racing Commission will license your trainer as your "Authorized Agent" in order to provide your trainer with access to your account. There are varying degrees of "permissions" to your account, and the Racing Commission will be happy to assist you with these matters.

# Q- I want to claim a horse and will be wiring the funds directly into my account. How is this procedure handled?

A- Any of the Horsemen's Bookkeepers will be happy to provide you with wiring instructions for direct deposit into your account. Please be aware that wires initiated late in the day on Fridays may not be received by the bookkeeper in time for a claim during the weekend. If possible, you should initiate wire transfers 24 hours before the funds will be needed, except on Fridays and weekends, when you should initiate the wire on the previous Thursday.

### **Q- I** want to cash a check at the track teller window. Why does the bookkeeper have to approve it?

A- As a service to horsemen, the tracks have agreed to cash checks for horsemen with the bookkeeper's approval and guarantee of available funds. The bookkeeper will verify that you have an active account within the bookkeeper system, and by approving the check, she is guaranteeing that the check will clear. Any returned checks are presented to the Horsemen's Bookkeeper by the track for collection. There will be a \$35 fee for all returned checks, and you may be place on a "do not cash" list. Each racetrack has limitations on the amount that can be cashed with bookkeeper approval. Checks for amounts that exceed the approved limit must be approved by track personnel.

Following the conclusion of the Thoroughbred season on March 11, Sam Houston Race Park will host its 2014 American Quarter Horse Meet with 24 days. Live Quarter Horse racing will begin on Friday, March 21 and continue through May 11.

Funding for the THP is derived from several sources, including a contractual deduction from the purse accounts at each track, corporate sponsorships, revenue generating programs initiated by the THP and interest from treasury management. Therefore, no direct dues are required from any single member.

The Texas Horsemen's Partnership conducts numerous programs and services aimed at improving efficiency and enriching the lives of ALL horsemen at our tracks in Texas. # RETRAINING RACEHORSES BACK to the BASICS
